Public Policy Paper Proposal

Review the requirements for the Final Public Policy Paper listed below and then, develop a twopage, APA-style paper in which you propose the topic and major elements defining the Final Public Policy paper. The Public Policy Proposal paper will be written in four parts:

- Identification and explanation of the topic including a problem statement
- The explanation of the research process; that is, how will the research be conducted
- A discussion of relevant literature appropriate to the issues at hand
- An abbreviated reference list (a minimum of three sources).

Final Public Policy Paper

The fifteen page paper should integrate readings, discussions, field research, and any literature review into proposed solution. It may include explanation and examples from previous experiences as well as implications for future applications.

The paper should focus on a topic, which was submitted in the Public Policy Proposal Paper. In this paper, you will examine a specific political or social issue. Topics may include general issues such as poverty, crime, homelessness, economic development, homeland security, corporate social responsibility, ecological/environmental projects, etc. or a specific issue in your city, community, local, state, or federal governmental, etc. You will:

- Develop a public policy to address the issue. Or you may propose a change or update to an existing public policy.
- In all cases, the focus should be on in the development of a public policy, to include utilizing all aspects of the public policy lifecycle.
- Consider use of field assessments, literature searches, personal knowledge/experience, and community records to source content.

Writing the Final Paper

The Final Paper:

- Must be twelve to fifteen double-spaced pages in length, and formatted according to APA style.
- Must include a title page with the following:
 - Title of paper
 - Student's name
 - Course name and number
 - Instructor's name
 - Date submitted

- Must begin with an introductory paragraph that has a succinct thesis statement.
- Must address the topic of the paper with critical thought.
- Must end with a conclusion that reaffirms your thesis.
- Must use at six scholarly sources.
- Must document all sources in APA style.
- Must include a separate reference page, formatted in APA style.

Below Expectations - Insufficiently analyzes how the policy process will develop regarding the public policy.

Non-Performance - The analysis of how the policy process will develop regarding the public policy is either nonexistent or lacks the components described in the assignment instructions.

Restatement of the Thesis and a Conclusion Paragraph

Distinguished - Provides a detailed and complete restatement of the thesis and a strong concluding paragraph.

Proficient - Provides a restatement of the thesis and a concluding paragraph, but is missing one or more key details.

Basic - Provides an abbreviated restatement of the thesis, and a limited concluding paragraph. More detail needs to be provided to be considered complete.

Below Expectations - Briefly restates the thesis and provides no concluding thoughts or recommendations in the final paragraph.

Non-Performance - Both the restatement of the thesis and the concluding paragraphare either nonexistent or lacks the components described in the assignment instructions.

Written Communication: Content Development

Distinguished - Uses appropriate, pertinent, and persuasive content to discover and develop sophisticated ideas within the context of the discipline, shaping the work as a whole.

Proficient - Uses appropriate and pertinent content to discover ideas within the context of the discipline, shaping the work as a whole.

Basic - Uses appropriate and pertinent content, but does not apply it toward discovering or developing ideas. Overall, content assists in shaping the written work.

Below Expectations - Uses content, though it may be unrelated or inappropriate to the topic. Content does not contribute toward the development of the written work, and may distract the reader from its purpose.

Non-Performance - The assignment is either non-existent or lacks the components described in the instructions.

Basic - Displays basic comprehension of syntax and mechanics, such as spelling and grammar. Written work contains a few errors, which may slightly distract the reader.

Below Expectations - Fails to display basic comprehension of syntax or mechanics, such as spelling and grammar. Written work contains major errors, which distract the reader.

Non-Performance - The assignment is either non-existent or lacks the components described in the instructions.
